With the exception of three cases pending their court hearings in the next two months, I have successfully completed the forty-six (46) cases I've been assigned to as Guardian ad Litem or Court Visitor since admission to the Kitsap County GAL Title 11 Registry on July 1, 2017.

Prior to my eight years' service on the Title 11 registry I spent 10 years as lay or de facto guardian for my mother as she advanced through Alzheimer's from moderate to severe incapacity, from 2008 until her death in January 2017. With the aim of allowing her to remain in her home as long as possible, I worked with my five siblings to provide an expanding array of support as her cognition deteriorated and until she had to go into residential/memory care the last year of her life

Also relevant to the investigative, analytical and reporting aspects of my guardianship work was the 40 years I spent as a journalist and foreign correspondent researching, fact-finding, investigating, interviewing and analytical report-writing on my coverage of armed conflict, natural disasters, international development, diplomacy, relief work, legal affairs and foreign policy through eight U.S. administrations.
