PLEASE NOTE: <u>Order Appointing Guardian ad Litem should authorize 2X my initial deposit without further order of the court.</u>


Initial Deposit: \$2,500.00 payable by cash, money order or bank check and must be paid in full before the work commences.

Hourly Rate: \$125.00 per hour, billing will be made in 1/10th of an hour which will include travel time.
