PURPOSE OF THE ZONING USE TABLE UPDATE

Reduce barriers to investment in Urban Growth Areas (UGAs), Limited Areas of More Intense Rural Development (LAMIRD), and Rural Commercial and Rural Industrial zones:

Housing Equity and Diversity

Provide opportunities to develop:

- "missing-middle" housing
- attached housing
- multi-family housing
- accessory dwelling units

Economic Development

Provide opportunities to support:

- Scaling land uses to streamline the level of permit review required
- Adding new land uses

Make the Code Easier to Use

- Add, repeal, or revise definitions
- Restructure footnotes
 and reduce surprises
- Modify allowed use table format
- Transfer categorical uses into the allowed use tables

Consideration (July 2021 – March 2022)


Develop Draft – Formal Proposal:

- Department of Community Development to review all comments and develop a formal proposal
