#### General Election Local Voters' Pamphlet – November 2, 2021



Dear Kitsap County Voters:

"Please come watch our process in person."

This is one of the most common responses we offer to voters who have questions, and sometimes concerns, about how we process ballots during an election. Please come watch our process in person.

You have, no doubt, heard the phrase "Sunlight is the best disinfectant." It's a statement with roots in poetry by Ralph Waldo Emerson in 1860. But it also works literally in science and these days is most associated with government openness.

For the past several years the Kitsap County Auditor's Office has sought ways to get more people witnessing what we do. It's one of the reasons we installed a webcam that shows the main processing room.

For in person observation, we've traditionally made written invitations to both Kitsap branches of the major political parties, and they consistently have observers in the room when we process ballots. But you don't have to be tied to a party to watch us work in person.

This year we will offer an evening training on October 18 for anyone interested in learning how the process works. We'll meet to talk about how we do what we do, the rules we follow and how observers can get their questions answered as the work continues. Look for the ad later in this pamphlet for more details.

We are grateful to do the work we do, carrying out a vital function of American democracy. This election features races for some of the offices that have the most direct impact on Kitsap residents, and we hope to do all we can to provide the information you need. That includes what's in this pamphlet. Use this as a guide to learn about your candidates, ballot measures, deadlines and where you can deposit your ballot. This is one more way we work to let in more sunlight.

#### **Voter Information**

#### **State Measures**

The Secretary of State's Office will publish a voters' pamphlet that includes all statewide measures. The state pamphlet will be delivered by the U.S. Post Office to all households in Kitsap County and is also available online at: www.votewa.gov.

#### **General Election Ballot**

State measures will appear on the ballot followed by local offices and measures.

If a Primary was held, the two candidates that received the most votes in the Primary and received at least 1 percent of the votes cast for that office appear on the General Election ballot. The candidate that received the most votes in the Primary is listed first. Candidates that did not appear in the Primary are listed in the order determined by lottery draw.

#### Questions or Need a Replacement Ballot?

If you have not received your ballot by **Oct. 21** or if your ballot is damaged or lost, a replacement may be obtained by calling the Kitsap County Auditor – Elections Division at (360) 337-7128.

#### Military, Overseas and Early Ballots

If you are a military or overseas voter or if you believe your ballot will not be received in time to vote, you may request your ballot be sent by email or request an early ballot up to 90 days before an election. Early ballots list only contests known at the time of the request. To request an email ballot or early ballot, visit: <a href="kcowa.us/earlyvote">kcowa.us/earlyvote</a> or call the Kitsap County Auditor – Elections Division at (360) 337-7128.

#### Your Right to Privacy

Every voter has the right to vote his or her ballot in secret. A person voting when he or she is not qualified, or falsely signing the Voter Declaration, is a felony punishable by up to five years of imprisonment or a maximum fine of \$10,000, or both imprisonment and fine.

#### **Email or Faxed Ballots**

You may request that a ballot be emailed or faxed to you by contacting the Kitsap County Auditor's Office. Almost all voters still must return ballots by mail or dropbox.

#### Write-Ins - Which Votes Can Be Counted

Write-in votes can only be counted if:

- The candidate filed a declaration of Write-in Candidacy, and;
- In a General Election there are enough write-in votes for a candidate to win, or in a Primary if there are enough votes for a candidate to come in second place.

#### **Register to Vote**

#### **Who May Vote**

To be eligible to vote, one must register and be:

- A citizen of the United States.
- A legal resident of the state of Washington.
- 18 years of age by the next election.
- Not under the authority of the Department of Corrections for a Washington felony conviction.
- Not disqualified from voting due to a court order.

#### How to Register

- Online at <u>www.VoteWA.gov</u>.
- Complete a mail-in registration form available at libraries, city halls, public schools, fire district offices and at the County Auditor's Office.
- When you renew your driver's license.

#### **Update Your Voter Record if You Move**

If you are already registered to vote in Kitsap County, update your voter record online at: <a href="www.VoteWA.gov">www.VoteWA.gov</a> through October 25. You may also email the Kitsap County Auditor — Elections Division at <a href="auditor@co.kitsap.wa.us">auditor@co.kitsap.wa.us</a> or call 360-337-7128. Address changes can be made in person until 8 p.m. on Election Day at the Kitsap County Auditor's Office and at the Vote Centers. Dates and locations follow. A new voter registration card will be mailed after your address change is processed.

#### When to Register

Individuals may register to vote at any time. To vote in the November 2 General election, the deadlines are:

- October 25: Deadline for mail and online voter registrations, updates and changes.
- November 2: In-person deadline for voter registrations, updates and changes. Citizens may register until 8 p.m. on Election Day by appearing in person at the County Auditor's Office. Registration will also be available the Saturday and Monday before Election Day and on Election Day at the Vote Centers at the Marvin Williams Recreation Center and the Poulsbo Fire Station.

#### Name Change

If you have legally changed your name, you must complete a new voter registration application. Your new signature is used to validate your ballot.

#### **To Cancel Your Voter Registration**

You may sign a form requesting to cancel your registration. In the case of a deceased voter, a family member may sign a form authorizing a cancellation. The form is available by contacting the Kitsap County Auditor's Office or at <a href="https://www.kitsapgov.com/auditor/Documents/CancellationForm.pdf">https://www.kitsapgov.com/auditor/Documents/CancellationForm.pdf</a>.

#### **Mark and Return Your Ballot**


#### How to vote

Use a dark blue or black ink pen to completely fill in the box to the left of your choice. **Do not use pencil**. Mark one choice in each contest. If you mark more than one choice, no votes will be counted for that contest.



#### Secure

Place the voted ballot in the secrecy sleeve. Place the secrecy sleeve inside the lavender return envelope.



#### Sign, Date and Seal

Read, sign and date the Ballot Declaration on the lavender return envelope.

- The lavender return envelope must be signed by you in order for your ballot to be counted.
- Sign your name in dark ink.
- Seal the lavender return envelope.



#### **Ballot Drop Boxes**

#### Mail

Mail your ballot early enough to be postmarked on time. We recommend you mail your ballot by Oct. 26, one week before voting ends.

#### **Vote Centers and Accessible Voting**

Federal law requires jurisdictions to provide vote centers with certified accessible voting devices which enable voters with disabilities to cast their ballots independently and in private. Accessible Voting Units provide all contests in audio and high-contrast text formats and are available beginning 18 days prior to the General Election.

#### **Online Ballot Access**

Kitsap County Elections provides an accessible online Local Voters' Pamphlet. The online pamphlet also allows voters to access their specific ballot using the internet.

It is compatible with commonly used accessibility software such as screen readers and screen magnifiers, and allows for navigation without the use of a mouse and without having to see the cursor on the screen. All candidate video statements are close captioned.

Through Online Ballot Access at <u>VoteWA.gov</u>, you may verify that Kitsap County Elections has received your ballot using the Ballot Status feature.

Online Ballot Access is available beginning 18 days prior to the General Election at: VoteWA.gov.

#### **24-Hour Ballot Drop Boxes**

Voters are encouraged to use a ballot drop box. Ballot drop boxes provide a safe, secure way for voters to deposit their ballots.

Ballot drop boxes are available 24 hours a day beginning Oct. 15, 2021, until 8 p.m. on Election Day.

## Kitsap County Proposition No. 1

## Office of Kitsap County Medical Examiner

The Kitsap County Board of Commissioners adopted Resolution No. 098-2021 proposing creation of the Office of the Kitsap County Medical Examiner. If this proposition is approved, the current County Coroner's office will be replaced with an Office of the Kitsap County Medical Examiner, effective January 1, 2023 (or sooner if the Coroner's office becomes vacant before then), in accordance with RCW 36.24.190. The new office will be a department of the government of Kitsap County, having all of the rights and duties set forth in the Revised Code of Washington, including chapters 36.24 and 68.50.

#### Kitsap 911 Emergency Communication Systems and Facilities Sales and Use Tax

The Kitsap County Board of Commissioners adopted Resolution No. 114-2021 concerning an emergency communication systems and facilities sales and use tax. If approved, this proposition would authorize the imposition of an additional one-tenth of one percent of sales and use tax for a total rate of two-tenths of one percent (0.2%) for the purpose of providing funds for Kitsap 911 for costs associated with financing, design, acquisition, construction, equipping, operating, maintaining, remodeling, repairing, reequipping, and improvement of emergency communication systems and facilities, pursuant to RCW 82.14.420.

## **Proposition No. 1 Office of Kitsap County Medical Examiner**

The Kitsap County Board of Commissioners adopted Resolution No. 098-2021 proposing creation of the Office of the Kitsap County Medical Examiner. If this proposition is approved, the current County Coroner's office will be replaced with an Office of the Kitsap County Medical Examiner, effective January 1, 2023 (or sooner if the Coroner's office becomes vacant before then), in accordance with RCW 36.24.190. The new office will be a department of the government of Kitsap County, having all of the rights and duties set forth in the Revised Code of Washington, including chapters 36.24 and 68.50.

#### **Argument For the Measure**

An appointed physician who is or will be a certified forensic pathologist will bring a modern and up to date approach to death investigation in Kitsap County. This will also bring neighboring counties looking towards Kitsap County as a regional source for a certified forensic pathologist to perform autopsies and death investigations.

We have relied on an elected official layperson for decades to act as Coroner while contracting out forensic pathology services to determine causes of sudden, unexpected, violent, suspicious or unnatural deaths. A savings should be seen by bringing the services in-house even with the higher cost associated with a medical examiner. It is time Kitsap County entered the 21st Century and had an appointed physician acting as the medical examiner and eliminating the need for an elected Coroner.

This will bring an up to date, more modern and technically driven approach to the new Office of the Kitsap County Medical Examiner. There is also potential monetary savings and potential new revenue for Kitsap County by changing to an appointed Medical Examiner vice an elected Coroner.

## **Explanatory Statement** (Prepared by the Office of the Kitsap County Prosecuting Attorney, as prescribed by law.)

The Law as It Presently Exists: Currently, investigations into the cause and manner of the death of persons in Kitsap County are performed by an elected county coroner. The elected county coroner is typically a layperson who must contract with one or more certified forensic pathologists to perform autopsies and provide medical expertise in death investigations. By contrast, the medical examiner system is widely considered to be the modern, streamlined approach to death investigation because it is operated by an appointed physician who is certified as a forensic pathologist by the American Board of Pathology. On the recommendation of the County's current elected coroner, the Kitsap County Board of Commissioners has proposed replacing the coroner system with the medical examiner system. This change requires the approval of a majority of voters in the County.

The Effect of the Proposed Measure if Approved: If this measure is approved, the current County Coroner's office will be replaced with an Office of the Kitsap County Medical Examiner, effective January 1, 2023 (or sooner if the Coroner's office becomes vacant before then). The new office will be a department of the government of Kitsap County, having all the rights and duties set forth in law with respect to county coroners.

#### **Argument Against the Measure**

Changing from a Coroner system to a Medical Examiner system at this time is not a good idea for the following three reasons:

- 1. You as voters will lose the ability to put the right person with the responsibility of investigating your loved one's death. The Coroner is currently elected but a Medical Examiner would be appointed and supervised by the County Administrator. Currently, the Coroner is independent and responsive to the community's needs by being involved in all committees relating to preventing premature death. Medical Examiners are pathologists and the Administrator of the office.
- 2. All of the six, out of 39 counties in Washington State who currently have a Medical Examiner system waited until they had a population of at least 400,000 because of the added expense of running such a system. A highly paid pathologist, autopsy assistant, medical transcriptionist, histology requirements and clinical tests would need to be added to the budget.
- 3. Medical Examiners does not equate to good administrators as we have seen from examples in Snohomish and Pierce Counties. In Snohomish, the county decided to take the administrative duties away from the M.E. because of the many problems there, adding an additional expense and level to the budget.

In conclusion, the check and balance system we now have in the Coroner system works and should not be changed without good reason.

#### **Rebuttal to the Argument Against**

A qualified Medical Examiner is the right person to have the responsibility of investigating a death. Taxpayer dollars spent on outside expertise can better be used in-house. A Medical Examiners office will bring needed local services to the Kitsap and Olympic Peninsula regions, with potential to actually bring in additional revenues.

You are being told that Kitsap County will save money by going to a Medical Examiner system. # Proposition No. 2 Kitsap 911 Emergency Communication Systems and Facilities Sales and Use Tax

The Kitsap County Board of Commissioners adopted Resolution No. 114-2021 concerning an emergency communication systems and facilities sales and use tax. If approved, this proposition would authorize the imposition of an additional one-tenth of one percent of sales and use tax for a total rate of two-tenths of one percent (0.2%) for the purpose of providing funds for Kitsap 911 for costs associated with financing, design, acquisition, construction, equipping, operating, maintaining, remodeling, repairing, reequipping, and improvement of emergency communication systems and facilities, pursuant to RCW 82.14.420.

#### **Argument For the Measure**

Kitsap 911 is asking Kitsap County voters to support a sales tax of 1/10 of 1%. The money generated by this tax will be used to replace and upgrade the emergency radio communications network serving Kitsap County and provide for Kitsap 911's future infrastructure needs. Kitsap 911 provides emergency communications and dispatch for all Fire, EMS and Law Enforcement agencies in Kitsap County. This vital service operates 24 hours a day and links the 911 caller with the help they are requesting.

The current radio communication system and infrastructure is failing and does not provide reliable emergency communications in many areas of Kitsap County and cannot accommodate the volume of radio traffic required during significant emergencies putting the public, first responders and property at risk. Segments of the current emergency communications infrastructure are obsolete and are no longer supported by the manufacturer or are at end-of-use/life.

The State Legislature has authorized counties to ask voters for this local sales tax to fund emergency communications. The time is now to update this critical system to state of the art technology. Kitsap 911's Board has directed that the revenues generated by this measure will fund a complete radio system replacement and thereafter create a committed Capital Improvement/Equipment Replacement Reserve for the indefinite future.

The service provided and equipment used by Kitsap 911 is essential for the safety of Kitsap County residents, visitors and first responders. Please support this important public safety measure by voting "Yes".

#### **Rebuttal to the Argument Against**

Kitsap 911's request for additional funding is the result of careful planning. Current revenues are not adequate to meet Kitsap 911's future capital improvement, equipment replacement, and operating requirements. That is why additional funding is necessary. Kitsap 911 needs more than a "one-time" upgrade. Revenue will be used for funding the costs associated with financing, design, acquisition, construction, equipping, operating, maintaining, remodeling, repairing, re-equipping, and improvement of the Kitsap 911 emergency communication systems and facilities.

**Explanatory Statement** (Prepared by the attorney for the district, Kitsap 911, as prescribed by law.)

Kitsap 911 is the consolidated countywide dispatch center for all fire/EMS and law enforcement service agencies in Kitsap County. Kitsap 911 is responsible for receiving all emergency 911 calls and dispatching the appropriate police, fire, or emergency medical assistance to emergencies reported. This proposition would authorize an increase to the countywide sales and use tax by onetenth of one percent or one cent on a ten-dollar taxable purchase for Kitsap 911 for its emergency communications system. The increase is needed to modernize Kitsap 911's current end of life analog radio system with a new digital emergency communications system. The digital system will increase coverage, provide more capacity and allow better communications between and among first responders and dispatchers. Every first responder relies on the system for their safety and the safety of the public. Tax proceeds would be used for the sole purpose of funding the cost associated with financing, design, acquisition, construction, equipping, operating, maintaining, remodeling, repairing, reequipping, and improvement of the Kitsap 911 emergency communication systems and facilities.

#### **Argument Against the Measure**

Just Say No to a Forever Tax for a One Time Upgrade K911 has been aware of these required technology upgrades for several years. Their lack of planning for the future is being passed down to the citizens of Kitsap County. How much has been saved from year to year since they knew? This is a *one time* technology upgrade, yet the tax will never go away. No reason for a forever tax has been given & little to no detailed plans of how the funds will be used have been provided.

Sales Tax Increases Unfairly Affect Low Income Residents
Any sales tax increase is regressive & unfairly impacts the middle class & lower income. While no one disagrees that 911 service is essential, raising sales tax forever is not fair because it creates a bigger burden on those already disadvantaged.

#### 911 Service Is Already Funded from Multiple Sources

Take a look at your phone bill, both landline and wireless, and you will see you already pay a monthly 911 tax. (Even this tax was originally given a sunset date, but of course became a forever tax.) This is just one of many examples of how there are existing funding sources for K911. There are now more people than ever paying the existing 911 taxes, generating more funds, yet their lack of planning & accountability has led to this measure. The 2019 Annual Report from K911 claimed they completed all needed technology upgrades, what happened?

#### Rebuttal to the Argument For

Vote No on the Kitsap 911 measure. No justification or details have been given to warrant a sales tax increase that lasts forever. They are assuming their lack of planning for the future will continue, which will lead to not having enough funding for upgrades. Does that warrant a new capital improvement fund? 911 already has multiple funding sources. This sales tax increase should have an end date.

## **Election** Voting Facts and Tips



Track your ballot. Go to VoteWA to see if your ballot has been sent to you, received by us and then accepted.

Be on time! Our ballot drop boxes close at 8 p.m. sharp on election night and mailed ballots MUST be postmarked no later than election day. If you have any doubts about whether your ballot will be postmarked on time, use one of our 25 drop boxes.



If you register online to vote, your signature comes from the Department of Licensing. If you match your signature to what's on your driver's license or what's on your state ID, your chances improve of having your signature match.



Don't sign someone else's ballot envelope for them, even for someone in your same household who is away.



Power of attorney cannot be used to sign someone else's ballot. If the voter cannot sign, have them make any mark on the declaration and have two witnesses sign in the spaces provided below the mark.



Our processes are public. Come watch us in person, or go to kcowa.us/elections and watch via the webcam.

Beau "Gus" Moniker If you write in a fake name on the ballot in a race, the write-in vote will not be recorded.



Ennosent Bystander

If you choose to not vote in one race, your votes in the other races still count.



Ballots are mailed to voters by 18 days before the election. For most elections most ballots arrive to Kitsap households when there are still at least two weeks before election day. It's not the norm, but sometimes voters in the same household receive their ballots on different days. If you don't have your ballot by October 21, feel free to email or call our office to check on the status.



Nothing on the ballot identifies you individually. The three bar codes show what election we're in, the precinct, a unique identifier of that single ballot (to prevent a ballot being scanned more than once) and the different page sides. Once a ballot is removed from an envelope, still in the secrecy sleeve, there is no



We test our ballot tabulation system before the election and do a random batch audit the day after the election to ensure that the system is counting ballots correctly. Both events are open to the public.

way to link the actual ballot to an individual voter.
