Proposition No. 1 Veterans and Human Services Levy

The Kitsap County Board of Commissioners approved Resolution Nos. 123-2011 and 124-2011 concerning funding for veterans, health and human services. This proposition would fund capital facilities and services that reduce medical costs, homelessness and criminal justice system involvement, with half of the proceeds supporting veterans, military personnel and their families, and the other half supporting other families in need. It would authorize Kitsap County to increase its projected regular property tax levy rate of \$1.10 by up to 5 cents per \$1,000 of assessed valuation, to \$1.15, for collection in 2012, with levy increases in each of the following five years limited as provided by chapter 84.55 RCW.
