### Dozens of pets found in squalid Chico house

SILVERDALE — The Kitsap Humane Society is seeking volunteers and donations to help treat 36 pets — 26 small dogs among them — that were recovered earlier this week from a house

in Chico described as squalid, with no light or ventilation. The owner of the house lives in another county and told authorities they visited the house every other day to care for the animals, though reports on the conditions of the home indicate the pets were suffering from extreme neglect. Although the animals showed symptoms

of skin and dental disease, and many are fearful of humans, none had to be euthanized.

The rescue has essentially filled up the shelter, and while these pets are not yet ready for adoption, the humane society has other pets in need of

homes. Those interested in adopting the pets rescued from the Chico house can contact the organization by email at [customerservice@kitsap-humane.org](mailto:customerservice@kitsap-humane.org) to receive updates.

Kitsap County Animal Control Supervisor Chase Connolly said when authorities first went to the house on Tuesday, conditions were among the worst he had ever seen.

"This is probably one of the worst I have seen in eight years in animal control," he said, adding that the case is being investigated for possible animal cruelty charges.

"Many of the dogs were kept in filthy cages, while others were free to run loose in the home," according to a post on the Kitsap Humane Society's blog. "Two dogs were found locked in a laundry room where they had no access to sunlight. Throughout the house, feces covered the floor, trash littered every surface and rats ran amuck while officers canvassed the home assessing the situation."

In addition to the 26 small-breed dogs, authorities rescued five rabbits, four cats and a guinea pig. The cats have shown symptoms of skin ailments and are "extremely fearful" of people and are being kept in a quiet part of the shelter, but are doing well. The rabbits appeared to be in generally good health and are in foster care, according to a post on the Kitsap Humane Society's blog.

Before the animals can be prepared for adoption,

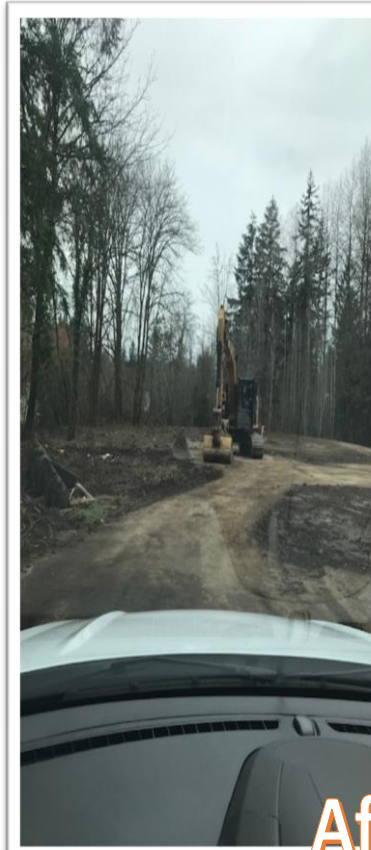
the Humane Society is seeking volunteers — including foster homes — and donations to treat their medical needs, said Rhonda Manville, marketing director.

"All of this is expensive," Manville said. Friday's update said the animals will likely be at the shelter receiving treatment for several weeks.

The dogs were in need of grooming, but an update Friday said most have been bathed thanks to two grooming businesses whose customers voluntarily canceled their appointments. Six veterinary practices donated services to help treat the animals as well.

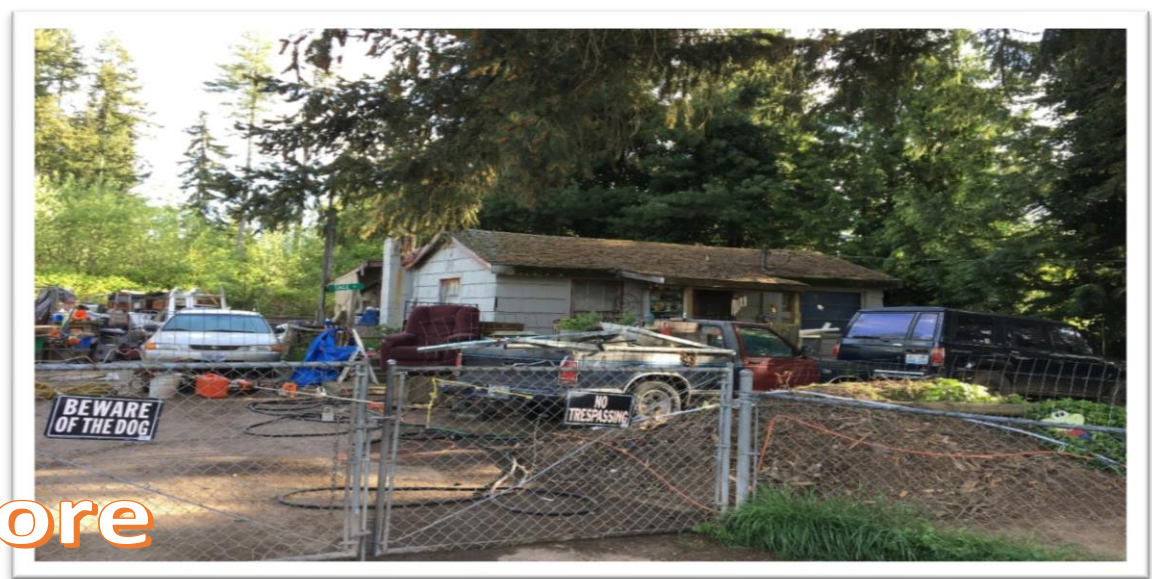
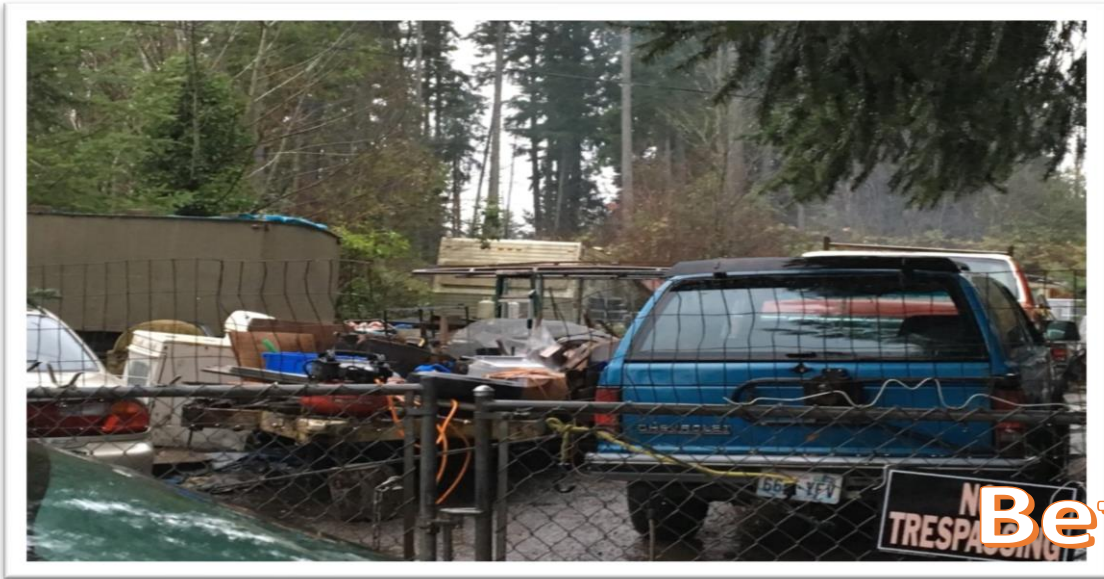
