Capital Projects Program

Port Gamble Forest Heritage Park - ride park and parking lots

Phase 1 of ride park construction is nearly complete, and work has shifted to Phase 2 trails. Risk Management did a walk-thru of the project site on February 10 to assess progress; no glaring concerns were noted at this stage of development.

The permit application package for the Stottlemeyer parking lot has been submitted to DCD and final design work is underway for the ride park parking lot; its permit application is estimated to be submitted to DCD in February. A Conversion Option Harvest Permit (COHP) was submitted in early February for the area surrounding the Stottlemeyer parking lot and trailhead. Approval of COHP is required before the construction permit will be approved.

Events and Facilities Rental Program

Events and Rentals

Due to the spreading Omicron variant, staff saw an increase in event cancellations for the over the last month. As Covid case numbers rose, incoming reservation requests slowed down. However, now that cases are declining, we anticipate reservation requests to rise again. The current event totals for 2022 are included.

COVID Testing Site

The agreement with the Department of Emergency Management for COVID-19 testing at the fairgrounds, originally expected to expire on 12/31/2021, has been extended to 2/28/2022.

Historical Invoicing

In March 2020, the BoCC approved the *Facility Reservation Service Guide* that updated the facility rental policies and fee structure. With the COVID Pandemic impacting and postponing events for two years, the Parks Department is still implementing its new procedures and fee structure with facility renters. As events are coming back online, staff are working hard to communicate and support renters with the updated policies and fee structure; however, these are challenging conversations. Staff will present an overview of historical invoicing.

Kitsap Fair and Stampede Association

Parks staff have monthly meetings scheduled with Kitsap Fair and Stampeded Association to collaborate for the 2022 Kitsap Fair and Stampede event.

Maintenance & Operations Program

Weathering the Winter Storm

The clearing of the landslide and fallen trees at Anderson Point Park that were *in process* in January have been removed and fixed; the roadway from the parking lot to the beach is open.

A tremendous number of trees came down across the road and across park trails at Guillemot Cove Preserve. The road was cleared in January, but the trails had not. They are now, though, staff crews cleared 2.5 mile of trails that had been littered with fallen trees.

Toppling Trees

A tree at Nick's Lagoon toppled (root-ball pulled out of the ground) and damaged the corner of a neighbor's garage. The tree was removed and repairs to the garage are underway.

A tree at fell on top of a neighbor's fence next to Bill Bloomquist Rotary Park; the tree was removed, and the fence was repaired.

A tree assessment was performed at Illahee Preserve Heritage Park adjacent to private property. A contract for tree removal services is in process.

Ballfield Maintenance

The warming weather gave staff an opportunity to get a head-start on baseball and softball field maintenance; nearly all the infields in our park system have been rototilled and had new sand mixed-in.

Other

- Calvinwood the water system was drained, chlorinated, and flushed.
- o Salsbury Point and Wildcat Lake tree pruning has been completed.
- Veteran's Memorial Park on-going coordination with other departments and partners to provide park maintenance efforts from unauthorized encampments.
- o Painting of the interior part of the restrooms is in the works- in preparation for the parks opening date.
- Long Lake Park fencing repaired after a vehicle drove through it.
- Guillemot Cove Preserve lead abatement contractor to remove floor and wall tile inside the rental house.

Natural Resources Program

Forest Stewardship Program

Square Lake Park

Restorative thinning efforts to the 37 acres of the park south of Lake Flora Road delayed to an April start time due to a delay in availability by the contractor. Preparation work to clear and improve the entry "haul" road is underway. Tree seedlings to be planted by volunteers in areas of park that were thinned in 2021.

Wick's Lake Park

The Forest Stewardship Plan draft for Wick's Lake has been shared with community members for review and comment.

Volunteer Program

Recent Activity

Port Gamble Forest Heritage Park

- Trail repairs to The Hood trail that was damaged during the 2021 tree harvesting by Rayonier.
- Hundreds of native plants were planted in disturbed areas in the Ranger Trail corridor and along The Hood trail, project collaboration was with Stillwaters Environmental Center and the Mountain Vikes Youth Mountain Bike Team.

Hansville Greenway

 Hansville Greenway Association raised funding to assist Great Peninsula Conservancy acquire 100 acres of undeveloped land adjacent to Hansville Greenway. Plans to link and interconnect a trail network across property boundaries is in discussion.

North Kitsap Heritage Park

 Plants were harvested from one area of park to be used at as part of a restoration project at another area of the park.

Newberry Hill Heritage Park

- Work party with HOPE Worldwide to remove invasive plants.
- o Performed trail brush work and illegal trail decommissioning.

Banner Forest Heritage Park

o Trail work to fix drainage issues performed.

Illahee Preserve Heritage Park

- Spread gravel at main trailhead entrance to park.
- o Improvements to smaller trailhead off of Thompson Lane in-process.

South Kitsap Regional Park

 Partnership confirmed with Rotary Club of Port Orchard for funding of trail stream crossing project.

Howe Farm

 Planning in-process for construction of ADA trail from parking lot to apple orchard; trail to be lined with historic farming equipment donated to Parks.
 Project is a collaboration with students from South Kitsap High School and Rotary Club. Work is schedule for Earth Day (April 22, 2022)

Chico Salmon Park

Over a hundred native plants were planted.

Keyport Saltwater Park

o General park clean-up activities were performed.


Other
