Community Notification: Level III Sex Offender

PORT ORCHARD, Wash. -- The Kitsap County Sheriff's Office is releasing the following information pursuant to RCW 4.24.550, and a Washington State Supreme Court decision in <u>State vs. Ward</u>, regarding public notification of the anticipated residency of a convicted sexual offender.

"The person named in this advisory has been convicted of a criminal offense that requires registration with the sheriff's office in the county of residence," said Sheriff Gary Simpson. "Further, his previous criminal history places him in a classification level that reflects the *potential* to re-offend."

Name: Toby Eugene Sybil, white male, age 33.

Residence location: Mr. Sybil is relocating from Pierce County to Kitsap County. He has notified the Kitsap County Sheriff's Office that he will be residing in the 8800 block

of Conwhit Lane SW in South Kitsap.

A community notification meeting concerning Toby Sybil will be held at 6:30 p.m., Wednesday, March 4, in the Kitsap Room, Givens Community Center, 1026 Sidney Avenue, Port Orchard.

Criminal history: In 2005, in Clallam County, Toby Sybil was convicted of rape of a child, 2nd degree, when he engaged in a sexual relationship with a 13-year-old girl. He was next convicted of communication with a minor for immoral purposes when he continued to communicate with the same underage victim via sexually explicit correspondence from prison, and in violation of a no contact order. Two years earlier, Sybil had been convicted in Clallam County of assault, 4th degree, after continually harassing a 16-year-old girl with inappropriate sexual contact.

Mr. Sybil also was convicted of possessing a firearm on school property in 2004 along with another assault, 4th degree, conviction.

While in prison, Sybil completed sex offender treatment and was found guilty of serious infractions of prison regulations to include theft, drug / alcohol use, possession of sexually explicit material and mail / phone violations. In 2017 Sybil was convicted of two counts of no contact order violations (domestic violence), along with assault, 4th degree, and assault, 4th degree (domestic violence) convictions.

Additional information: As of Feb. 24, there are 22,372 sex offenders who have registered as required and are living in Washington state. Of this number, 807 are registered with Kitsap County Sheriff's Office.

Toby Sybil has served the sentences imposed on him by the courts. He has advised the sheriff's office that he will be living within Kitsap County. This person is not wanted by law enforcement at this time. This notification is not intended to increase fear. Rather, an informed public is a safer public.

The sheriff's office has no legal authority to direct where registered sex offenders may or may not reside. Unless court-ordered restrictions exist, registered sex offenders are constitutionally free to live wherever they choose. Passage of legislation entitled the "Community Protection Act of 1990," mandates sex offender registration which, in turn, has provided civil authorities the means to monitor where sex offenders reside.

Abuse of information provided through the sex offender notification process, to intimidate, harass or threaten registered offenders, will result in an investigation and the filing of criminal charges against the perpetrators.
